# **Tyrone Guthrie Bursary**

## **Residency at The Tyrone Guthrie Centre, Annaghmakerrig, Co. Monaghan**

*Please refer to the criteria below before completing the Application Form*

### **Application Criteria**

**For residencies taking place between 1 April 2025 – 31 March 2026**

**DEADLINE: Thursday 30 January 2025, 11:59pm (sharp)**

**Failure to meet the criteria as listed below in this document will result in your application not being assessed.**

This bursary award is for a one-week studio residency at The Tyrone Guthrie Centre, Annaghmakerrig. A maximum of four professional artists will be awarded for the 2025/26 financial year\*. Applicants may only submit one application form.

One of the available bursaries will be prioritised for an artist with a disability. Ards and North Down Borough Council are committed to supporting artists with disabilities across all art genres. This bursary is launched in memory of Chris Ledger, late CEO of the University of Atypical.

### **Who is Eligible?**

To be eligible you must meet all the following:

- Resident within the Ards and North Down Borough Council Area.

- A practicing professional artist in any arts discipline.
- Aged 18 years+.

**The applicant must be able to:**

- Demonstrate a high-quality professional practice.
- Have sufficient experience and significant achievement in their creative practice.
- Be able to clearly state what they wish to accomplish during their residency, and clearly outline the benefits the residency will provide for the applicant and their practice.
- The residency cannot start before 1 April 2025 and must be completed by 31 March 2026.

**The following essential documentation must be provided with your application:**

- Up-to-date Artist CV
- Support materials of your artistic practice (Images\* and other supporting materials where applicable: publications/examples of writing, audio recordings for examples of music, short video footage of performances, etc).

**It is recommended that you compile the essential documentation in the following formats before completing your application online, ready to be uploaded:**

- Up-to-date Artist CV (PDF document is preferable)
- Supporting materials in the following formats where applicable: (Images in JPEG or PNG format ONLY no less than 1MB, audio files no more than 60 seconds in length and less than 25MB, video files no more than 60 seconds in length and less than 25MB, publications / examples of writing preferable as one PDF document no more than one page in length per example)

*\* A maximum of 6 supporting materials can be provided. Images which show examples of artists' work should be of high quality/resolution and clearly demonstrate the work. If you require further information on photographing your artwork, see page 4*

**Failure to supply the requested essential documentation at time of application will result in your application not being assessed.**

### **Further Information**

Applicants should show significant achievement in their chosen field by providing supporting evidence appropriate to their particular art discipline. For example: writers should already have published in book form; visual artists should have had solo exhibitions in reputable galleries; composers, musicians, performers should have had their work commissioned, recorded or performed. Otherwise, the applicant must demonstrate a high degree of promise attested by references from established figures in the arts.

**Applicants who were successfully awarded a bursary to The Tyrone Guthrie Centre from Ards and North Down Borough Council in the previous financial year (1 April 2024 – 31 March 2025) will not be applicable to apply for the following financial year (1 April 2025 - 31 March 2026). Applicants in visual art/craft will however still be able to apply to the Ballinglen Arts Foundation Bursary for the 2025/26 financial year. Please note that priority may be given to those applicants who have not received this bursary before.**

## Scoring

Applications will be scored on the following criteria:

- Is the applicant resident within the Ards and North Down Borough Council area? (Yes/No)
- Quality of applicant's current artistic practice and experience of applicant (35%)
- Quality of work proposed, and applicant demonstrates how the residency will benefit their artist's practice/skills (50%)
- Applicant demonstrates a tangible outcome EG: exhibition, new body of work, publication, etc (15%)

## What happens to your Application?

- Applications for the Ards and North Down Bursary to The Tyrone Guthrie Centre are assessed after the deadline by a panel made of Ards and North Down Borough Council Officers.
- The deadlines for receipt of applications are published on the cover of the application form. Completed applications should be submitted via the online application form by the relevant deadline.
- Successful residency awards must take place between 1 April 2025 and 31 March 2026.
- Applicants should note that while careful consideration will be given to each application, it may not be possible to assist every applicant even if all the criteria are met.
- You will be contacted by email to inform you of the outcome of your application. This usually takes four – six weeks from the application deadline.

## Bursary Guidelines

- The Ards and North Down Borough Council Tyrone Guthrie Residency Award is for a one-week Studio Residency at The Tyrone Guthrie Centre. A maximum of four professional artists will be awarded for the 2025/26 financial year. Applicants may only submit one application form.
- Applicants must be aged 18 years+
- Applications are welcome irrespective of an individual's religious belief, political opinion, racial group, age, gender, sexual orientation, marital status, whether they have dependents or not, or whether they have a disability or not. Please be advised that those applicants who have indicated that they have a disability or a physical or mental impairment will be required to provide more detail if their application is successful to ensure their needs may be met through putting in place reasonable adjustments (if applicable). - Residency awards are subject to budget approval.
- Payment of the residency award will be made by Ards and North Down Borough Council directly to the Tyrone Guthrie Centre. No payment or financial award will be given to the successful applicant.
- Applications received after the stated deadline will not be assessed.
- The residency cannot start before 1 April 2025 and must be completed by 31 March 2026.
- Evaluation forms will be forwarded to successful applicants and must be returned one month after the completion of the residency.

## TIPS FOR PHOTOGRAPHING YOUR ARTWORK

- Position the artwork on a plain flat surface or hang on a wall, and position the camera looking straight at the artwork.
- Ensure the full artwork is shown in the photograph and not cropped.
- You may provide a detail/close up image of artwork if you have included a photograph of the full artwork as well.
- Use bright, indirect, natural light avoiding glare/reflections on the artwork or on glass of framed work.
- Do not use your camera flash.
- Do not include other objects in the photograph other than the artwork unless providing a high-quality photograph of the artwork in situ in a gallery space.
- Ensure that the photograph is clear (not blurred or too dark) and an accurate depiction of your artwork.
- Please ensure the photograph is of high quality and resolution.

## **DATA PROTECTION**

Ards and North Down Borough Council values your right to personal privacy. Personal information provided to the Council is processed in order to fulfil its obligations under the Arts and Heritage Strategy. Personal information will not be shared with any other organisation, unless there is a legal requirement to do so, and will be held for a period of seven years.
